Lost in tongues and Minds, Cognitive Revaluation

This book concludes that the term 'Irish Language' is a political gaff, originating in 1922 during the new Irish State formation under enactment of Irish law, and that prior to that, everyone thought was Gaelic/ Gaeilge / Gaidhlig/ Goidelic, or commonly known as Gaelic, they spoke. The politicalization of that culture polarized all the native Gaelic linguists on The Isles then, by differentiating speakers in other jurisdictions and regions from each other, when in fact they all spoke the same language and were understood together, even-though regional dialects differed within all jurisdictions. Those jurisdictions and regions included Ulster, Connacht, Munster, Leinster, Isles of Lewis, Hebrides, Highlands, Skye, Argyll. Shetland and Isle of Mann.

Since 1922, the Irish State commenced in Ireland, a rushed process of naming places in 'Irish', by the appointment of scholars, who at the time and without any relevant known knowledge or research, committed certain grave significant errors. In this report many important words that can be referenced and their interpretations, are at variance with the official status given to us by The State. Many of these state interpretations have emboldened the names of appointed officials acting as educational eunuchs proclaiming their genius to all educational establishments both in Ireland and internationally. While the intention at the time may have been considered an anointment of an independent political process, after the Civil War 1921 in Ireland, the ancient algorithms of the Gaelic language have not been adhered to responsibly. As a result, there are consequential significant cultural damages caused, that today can no longer be ignored, and in their present form are seen to ignite racism all over The Isles by default.

Queen Elizabeth 1st granted a Royal Charter to Trinity College Dublin in 1592 and no efforts have ever been made by The Government of Ireland, or since 1922 by The State, to research the Gaelic language prior to 800 bc. Politically it was convenient to allow myths and folklore prevail, and to focus only on one part of the origin of the Gaelic language, namely since the arrival of the Celts from Europe, and to proclaim a white only dimension, to what had earlier

been a major ancient black culture that endured on The Isles for many thousands of years prior to their arrivals.

Colonialization and Black Slaves in the Americas was practiced where white slave Traders from The Isles were once from black Africa, many generations earlier, and whos' family stories and close histories were never known between them, and had they been known slavery may not have happened. Today, being an islander on The Isles, for people of black decent, should no longer be lost in translation with their living close neighbors, and their embedded ancient culture should be resurrected and amended into the algorithm of their shared culture today.
