

Language is a Currency

All spoken languages are currencies with value and their price depends how much trust is given to it by the speakers. Like most currencies there is little value back up security such as gold, yet some fiat currencies have prime value over others. What makes the difference is the trust that is placed into it by the market .In this case those who speak and or use it.
