

Minds Directly From The Jungle

The Original Mindset on The Isles

This narrative is about Colins' tribe that has never recorded their own history or touched the experiences of the Nile River. They never knew the Pharaohs', Judaism, the Torah, the Koran, the Bible to name but a few. Colin's tribe did have a spiritual experience and was depicted as 'Seela na Gi' (Mother Nature), displayed in the museum in Tralee in Co. Kerry in Ireland. Many such effigies exist all over Britain too. They had their own dance and music that resonates to the sound of water, beating of drums and burning of bushfires, and they venerated the virile goat that continues to be practiced in Ireland at the Poc Fair in Kilorglin, Co. Kerry every summer. Their word 'potit' or wash water, was the precursor to the word Poteen and Whiskey now produced on the isles. They inducted the game of hurling used in Gaelic sports as practiced today on 'The Isles' with its unique name for a ball: 'caadi' (recorded official terminology in GAA - Irish sports organization) and 'cat' that acted as the precursor for cricket developed by the Irish Military in the British Army; and gave us the first word for their primal internet on 'the isles' as being 'Ooor', that demonstrated their primal experience for the fastest speed in their boating technology namely 'hooker'. They wrote their words orally on all the landscapes in Ireland and Britain and all these words / images, conjure their first experiences when they first arrived that we can now believe to be the beginning of communications in human life on the isles.

More importantly they had their own mindset that became their first human engagement, and this brought with them the first words spoken on the isles of Britain and Ireland unchanged and unblemished from the central jungles of Africa. This original mindset is what matters today on The Isles that was never known until now. Mindsets remain intact whatever language subsumes the earlier practices. Mindsets also endure subsequent outside encounters and war, DNA, and immigration etc. It remains cohesive because it is already defined by its territories and in Colin's case to be the islands of Britain and Ireland ...the islanders. This mindset prevailed for thousands of years by default, under the initial stewardship of the spoken Gaelic language and in modern times, uses both in English and Gaelic.

The original presence on the isles of this first settlement apart from some scatters of Neanderthal man on southeast coast of England marked the first settlement of homo-sapiens and they arrived more than 10,000 years ago and probably many more years earlier up to 50,000 years ago. What is important is that their first words spoken gave us a deeper insight about those times, no matter how soon you want to believe they first arrived, and what they should mean to us today, and to connect us with the landscape we live in on these islands. Those original words from their pure jungle pastures devoid of foreign

propaganda and outside interference takes us closer to how we really think and touch our earliest experience and where we live now on The Isles. Brexit is the symptom of this undefeated mindset. There has never been anything so profound in modern times to explain this extraordinary demand to claim what is their sense of belonging and the speed it unfolded. How this success happened is debatable. What matters is it did happen.

It was impossible for any other tribes of homo-sapiens religious or otherwise to arrive on The Isles prior to the departure of Colin's people at the mouth of the Senegal River and there are no records available to prove otherwise. This is what makes this story one that was never travelled.

What is this mindset on The Isles? In the Book of Muckcross, published before the Brexit referendum, homo- sapiens show a clear assertiveness of a willingness to act, to complete, to finish, and to succeed, and to do so promptly without procrastinating to a dawdle, that ultimately leads to a submission. This process of thinking remains uniform on The Isles and does not allow itself to succumb, that might change theirs as islanders. This forms the magnetic social cohesion that empowers their identity. On the world stage, The Commonwealth would be seen as their social projected product, a symbol of undivided union, that is liberal, free and with the alchemy to continue on a path of success and be seen to do so that is theirs.

The Continentals (from Cain's people) are different, and Shakespeare did show that in his soliloquy 'To Be or Not to Be, that is the Question'. He had borrowed these thoughts and words from the philosophers on the Continent in his time. This soliloquy is a procrastinating process that dithers and has no immediate conclusion. It reasons and reasons and reasons more before finally exercising a decision that is a final act of submission. This process better known as "convulsionary immobilism", or "bureaucratic sclerosis" takes a long time no matter how obvious the solution may initial seem to be beforehand. This is Plato to a form that has schooled many French Presidents and ministers who hold closely a favored philosopher as their mentor that they personally attach to themselves like a Japanese tamagotchi.

The philosophies of Plato do not have an earlier arrival on the isles from the continent that is marked by the Battle of Hastings and subsequently from the Middle-Ages. Today, this philosophy is continuously imposed now under the aegis of the EU Commissions in Europe and by stealth the Max Planck Institute. Would Brexit be a symptom of something deeper and more profound rather than the convulsive pernicious conspiracies we read in the 'newspapers that try hard to sell'. Can the holders of the Charter tutelage of the Gaelic language in Ireland be held by default responsible for failing in their privileged duties and responsibilities to inform their government sponsors and academics the truth? Can this be their fall into a form of opaque shallow reductionism and or foreign conspiracies that has resulted in Brexit, because damaged words used had allowed political discourse to become obfuscated hidden and misunderstood, and only added to confusion among the electorate on the isles? The lack of primal meanings in original form and the current inappropriate usage in both Gaelic cum English can only cause national chaos, destruction and banking

and financial calamity in the face of the powerful continentals and lead to no real progress or conviction, only infinite work in progress and no completed achieved goals. Further delays to recognition of an ancient history will amount to more mounting banking and financial losses on The Isles. It is essential that beliefs in the power of well ordained primal words become a recurrent concept in practice to understand and then be understood and conversed properly in an ordained algorithm similarly to how Napoleon made the French language unique and uniform. Until that happens the chaos of Brexit prevails indefinitely.

An analogy of how mindsets operate can be seen as a good example as explained by Ian Kehoe, Editor & Journalist in his article in Currency explaining the Irish government response as a result of Covid – 19 and his discussions with various Irish Liquidators:

‘Unlike the last crisis, the expert panel believed the current crisis will not be as deep. “There were three different governments over the period, and I think they all followed the same principles. There was a consistency of approach. We approached the recession a lot more like how the Americans approach a recession. You have a problem – you get to the bottom of the market quickly and then you deal with it immediately. You acknowledge ground zero as quickly as possible and then you rebuild again. A more European approach was to extend, pretend and manage and you never get to the bottom as quickly,” said McAteer’ Liquidator’.

Shakespeare’s soliloquy comes to mind. Also, can we presume that the success of the speed of delivery of the Covid- 19 vaccine to the UK to be another proof of this unique mindset. The continentals failed miserably, and their leaderships tarnished as a result due to their submission to bureaucratic sclerosis.

Before Caan and Colin went their separate ways their world was at one as a family where all members held trust and understanding and made progress together 'reading from the same hymn sheet': they both understood together. Mutuality and strong bonds flourished. This is what families are meant to be.

The current code of laws in the EU evolved from the experiences travelled by the tribe of Caan only. The same progress and cohesion and growth cannot be attributed to the practice on The Isles because theirs has never been completed properly on record and coded as they should. The ultimate responsibility lies with the Eunuchs of the Gaelic language that sit in ivory towers in Trinity College Dublin built by Queen Elizabeth 1st under Royal Charter and with enormous salaries just to be seen and not accounted for and the senior Irish civil servants that fail to show any critical original thinking in their mandate to administer and manage the state official languages. Denial is their excuse that only add to the demean of the Gaelic language and the English language by default and the resulting shackled joint consciousness narrows the limited area of experience that defines the islander’s inability to agree together, as nations should be. Consequential damage will be eternal and indefinite on the isles to be perpetrated by new invaders.....from the continent.

The original DNA of the original homo-sapiens do not form a major part of the ancient mindset currently prevailing on The Isles of Britain and Ireland. Mindsets absorb the mass of islanders and does not chose. Time is the essential ingredient to make that happen. Over many centuries this has matured, and nothing will change this, no matter what color hair,

eyes, skin a person has or what beliefs they follow. An example of this can be found in the discovery of an ancient dynastic syphilis ridden mummy of the great great great... grandmother of Mr Boris Johnson MP, a staunch Brexiteer, who's DNA has its origins in Central Europe.

Words are part of an ancient experience that is in continuum and they formulate together the construct of a mindset and a language when spoken today and can have different meanings between The Isles when said by different people on the isles between themselves, and that resulting 'joint official creole' will not be matched by force against the **body of language** that has arrived from the Commission of the EU because theirs is understood clearly and is intact and coded in law under perfect scripted layers championed by Napoleon that is unbreakable. Future fiscal and data management will fail to be controlled from the isles as a result and the English language will remain in a primary domain that functions in an operative state only that eventually will have no relevance in decision making on the world stage. That void will eventually be replaced by something different.

In the meantime, upon arrival, the Kingdom of Kerry became their new homeland and from here began their expanded family network settling along the southwestern coast of Ireland and finally creating their first metropolis to be known as Gangani, simply meaning the home settlement of their estuary fishing boats. The importance of this vast settlement was due to the ease to travel inland by boat through the whole country and accessing the far reaches of the hinterland, and the safety the Shannon Estuary (Senos) afforded them to return to the ocean again. In this settlement they replicated Shee Island on the Senegal River, to be known as 'don na gaal' or the isle of the gaal boat or simply 'the isles' (Citi of Lymericke), and on this island they built their place of spiritual practice and held their community meetings to make decisions. The arts of war were practiced, and the celebration of music and dance resonated all over this island. Boat building became the center of their new founded economy, and this evolved to other activities and brought other tribes together to market the spoils of their businesses and fraternize (Macolincon- Ptolemy). This island also afforded them to build fortifications to protect their community.

This above story should be seen to form part of the basis for the story of humankind since earliest times on the isles. Black People should feel empowered to embrace what is theirs and refute the linguistic disorder afflicting and abusing their rights to claim what should make them as they should be, and not as they are subjected to today. The public unconscious strategy perpetrating what is an inclusion, and an exclusion should be eradicated from practice. The demystification of their evidence that is their history should be seen to cease, what is seen to be the abuse of "cultural capital" that is usually aimed at flattering and reassuring those who are in the know and alienating those that are not.

Subsequently, expansion of many settlements continued throughout all the isles including the smaller islands and their words can be deciphered and their reasons why, from comparisons with the landscapes they refer to and or the activities practiced there. This exercise makes possible to observe the country as living in a museum of art and to experience a unique perception that has remained unchanged, and since has been blinded

due to passage of time. The story of Colin and his family has opened a new chapter that until now has formed a missing link in the evolution of the social order of humanity in the world. Visiting western seaboard along the Atlantic and watching the ebbing tides and the receding sun on a late evening imbue the presence of the earliest homo-sapiens and their first arrival and connect you with that story that now is in continuum and is all yours.
