Primal Tax Concept on The Isles

The words Tax and Cáin (Can*), both of which are found in the Irish Finance Acts, unknown to The Minister their intentions have been 'qualified in a time capsule', and now have been opened in this report that may undo much of the hardship taxpayers and mortgage holders suffer today. Currently taxpayers and mortgage holders are only allowed to make an appeal to a Minister denominated Appeal Commissioner and Bank Ombudsman, and do not have the choice of another independent qualified person that the taxpayer or borrower may have wished to select that was practiced by homo sapiens. This experience should embrace an unpropitious air of attraction that when inhaled the experience is never forgotten. Even though its ingredients may be seen to be vomitus and faecalis, its alchemy transfers into a rich perfume that attracts a high market value in society for the exchequer and fills the royal chrism that is good enough for a coronation.

In the absence of 'an urge' there becomes a void to be filled by a nearby tribe and the resulting societal edifice collapses to subsume to a new authority. To fuel the challenge to the deed, 'the urge' maintains the status quo and Dublin is the location.

A forlorn ultimate possibility, that the ritual of the European Court of Justice, to relegate the Irish tax sovereignty to a renegade flight of wild geese, and into the clutches of their EU teleological doctrines to enforce their executive powers and never to be seen again, is daunting.
